### **WEIGHT DIVISIONS**

Light, medium, and heavy weight. Super light and super heavy if necessary.

### **SENIOR DIVISIONS (17 - 29)**

FEMALE: 48 kg, 52 kg, 57 kg, 63 kg, 70 kg, 78 kg, 78+ kg  
MALE: 60 kg, 66 kg, 73 kg, 81 kg, 90 kg, 100 kg, 100 + kg

**MASTERS DIVISIONS** (30+) Male & female, to be determined by the number of competitors.

**DIRECTIONS TO THE SITE:** I---40 to exit 27; follow Highway 23/74. Take exit 102 to 276 south. At the 2<sup>nd</sup> traffic light (Burger King/Rite Aid) turn Left onto Howell Mill Road. Turn Right on Vance Street. Waynesville Parks and Recreation will be on your left at 550 Vance Street, Waynesville, NC 28786.

**REGISTRATION & WEIGH---IN:** Weigh---in will begin Friday during Coaches Clinic (5p---7p) and will continue Saturday, October 7<sup>th</sup> 8:00 – 10:00 am  
**COMPETITION BEGINS at 11:00 am, Saturday, October 7<sup>th</sup>**

**HEAD REFEREE – Dana Rucker**

**ELIGIBILITY** – Any current member of USJA, USJF, or USJI

**SCORING SYSTEM** – Modified Double Elimination or Round Robin for divisions with 5 or less Judoka.

**RULES** – IJF rules will govern the competition with modification for no shime---waza below 13 years old and no kansetsu---waza below 17 years old. IJF rules for below 13 years old for leg grabs will be a Shido for 1 offense.

**COST** --- \$30 for 1<sup>st</sup> division and \$15 for 2<sup>nd</sup> division. Competitors are only allowed to enter a maximum of 2 regular divisions– excluding the open division.

### **SPECIAL SENIOR OPEN DIVISION**

If there is enough interest we will offer a special senior open division for \$10 per person. All contestants will be sorted by weight from lightest to heaviest.

The competitors will be placed on a pool sheet and paired with the next competitor of the closest weight. Competition will continue in single elimination style until an eventual champion is crowned. The winner in each division will be presented with the coveted **FALL BRAWL CHAMP**.

Individual awards will be awarded for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place winners in each division.

Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, permanent disability, or death.
5. Release, waive, discharge and covenant not to sue the United States Judo, Inc.
