<u>ELIGIBILITY</u> – Any current member of USJA, USJF, USA Judo, ATJA, or AJJF.

<u>SCORING SYSTEM</u> – Modified Double Elimination or Round Robin for divisions with 5 or less Judoka.

<u>RULES</u> – IJF rules will govern the competition with modification for no shime-waza below 13 years old and no kansetsu-waza below 17 years old.

**<u>COST</u>** -- \$55 for 1<sup>st</sup> division and \$25 for 2<sup>nd</sup> division. Competitors are only allowed to enter a maximum of 2 regular divisions – excluding the open division.

## SPECIAL SENIOR OPEN DIVISION

If there is enough interest, then we will offer a special senior open division for \$10 per person. All contestants will be sorted by weight from lightest to heaviest. The competitors will be placed on a pool sheet and paired with the next competitor of the closest weight. Competition will continue in single elimination style until an eventual champion is crowned.
